

# 2010 MGA Mid-Amateur Championship

Conducted by the Memphis Golf Association

October 9 - TPC Southwind

October 10 - Chickasaw Country Club



**ELIGIBILITY:** Applications are open to members in good standing of Memphis Golf Association member clubs who are **age 25 or older by October 9, 2010**, meet the USGA definition of an amateur golfer and possess a USGA Handicap. Persons applying for reinstatement to amateur status are not eligible. All applications will be reviewed by the MGA to verify that each entrant has an official USGA Handicap Index®. Any amateur whose name does not appear on a recognized handicap roster will be ineligible and their entry application and entry fee will be returned.

**ENTRY DEADLINE:** All players must file an application by the entry deadline of **OCT 1, 2010 at 7:00 PM CDT** to be eligible to compete in the Championship. Late or incomplete applications are not accepted. Time limit for entries means receipt in the MGA office - not postmarked. The MGA is not responsible for misdirected mail. Entrants are urged to submit applications well in advance of the entry deadline to allow for postal delays. Faxed entry applications are not accepted. **THE MGA WILL NOT ACCEPT LATE ENTRY APPLICATIONS.**

**SOFT SPIKES POLICY:** All MGA events require the use of "soft spikes". Penalty for breach of this rule is disqualification.

**ENTRY FEE:** All Entrants - \$155 per player.

**SCHEDULE:** The competition will be an individual format conducted at stroke play over 36 holes.

**Saturday, OCT 9th:** Round one at TPC Southwind  
(Tee times will begin at approximately 12:00 p.m.)

**Sunday, OCT 10th:** Round two at Chickasaw Country Club  
(Tee times will begin at approximately 8:00 a.m.)

**Awards Ceremony:** Immediately following play on day two trophies and merchandise prizes will be awarded to the overall champion and runner-up, as well as merchandise prizes to the top finishers in each flight.

**NOTE:** Starting times for each round are estimates and subject to change. Official pairings and starting times will be released to all member clubs no less than 48 hours prior to round one and will also be made available online at [www.memphisga.com](http://www.memphisga.com).

**RULES OF GOLF:** Play will be governed by the USGA Rules of Golf and the most current MGA Rules of Play Card. All questions shall be settled by the Committee in charge of the competition, whose decision is final.

**CONDUCT CODE:** Penalties for breach of sportsmanship code (to include but not limited to property damage, abusive language, club throwing, excessive drinking or gambling) may include censure, suspension or revocation of playing privilege. USGA Decisions on the Rules of Golf - (US/33- 8/101).

**ACCEPTANCE OF PLACES / NOTICE OF WITHDRAWAL:** Any player wishing to withdraw from the tournament must notify the MGA at (901) 351-2207 immediately. This is to ensure a player on the waiting list has a fair opportunity to play. If a player fails to notify the MGA (901) 351-2207 that they must withdraw from the Championship, that player will be subject to a one year suspension from MGA events. Also, if a player fails to notify the official scorer of its withdrawal during the Championship, that player shall be subject to a one year suspension from MGA events.

**REFUNDS:** No refund will be issued after the entry deadline. A \$15.00 withdrawal fee will be charged to anyone withdrawing from the tournament prior to the entry deadline for any reason.

**CART POLICY:** Cart fees are included in your entry fee for all rounds. All players must ride during tournament rounds. Caddies will be allowed, but are required to walk at all times. **USE OF CARTS IS LIMITED TO CONTESTANTS ONLY.**

**MGA DRESS CODE:** Contestants must wear appropriate attire. Gym shorts, cut offs, shirts without collars, and denim shorts or pants are not acceptable. Mock turtlenecks are acceptable based upon the host club's policy. Shorts must be bermuda type in length.

**FOOTWEAR:** Traditional type spikes, regardless of composition, are prohibited at the Championship. Penalty for breach of this condition of play is disqualification.

**PRIZES:** Overall champion and runner-up will receive keepsake, crystal trophies. Merchandise certificates will be awarded to top flight finishers (# of flights based on field size).
